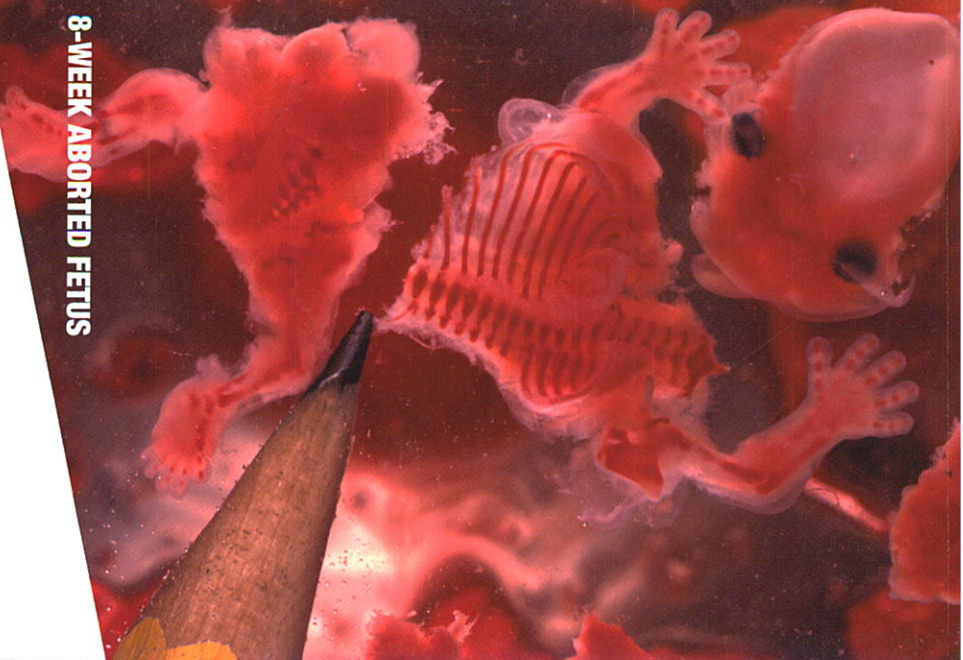

WHAT ABOUT DIFFERENT CIRCUMSTANCES?

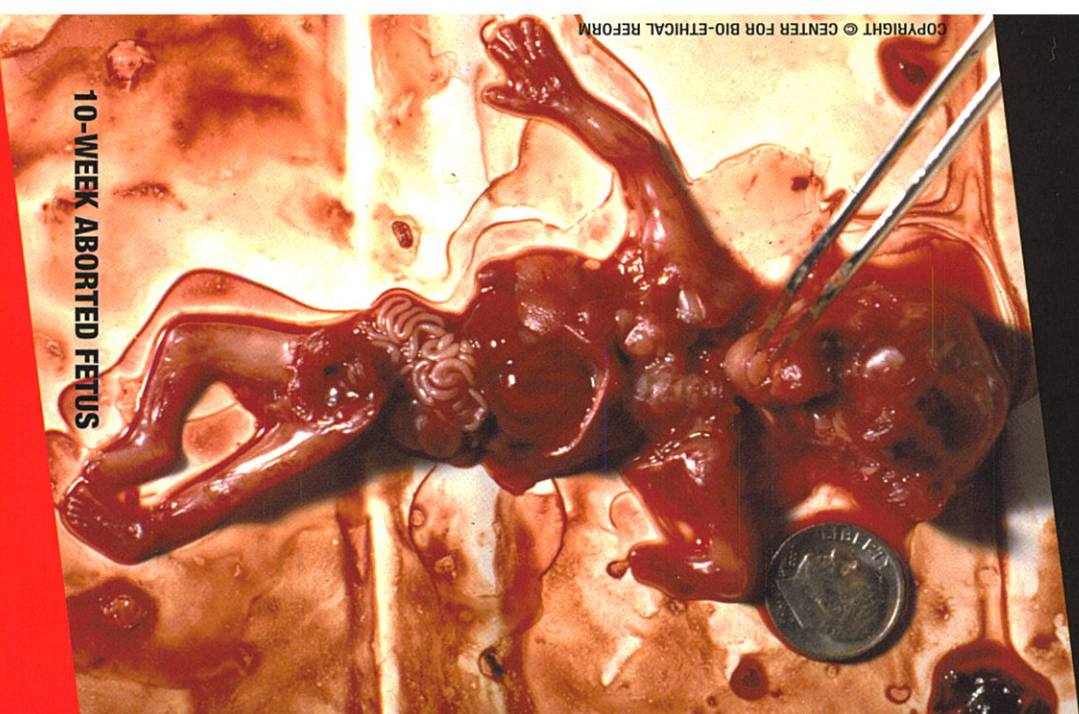
There are often difficult circumstances surrounding a pregnancy, just as there are difficult circumstances surrounding all stages of life. However, does that give us the right to kill human beings?
